

# Brazil Tax Conference 2020

19 de março de 2020 – São Paulo/SP

No mundo globalizado e transparente de hoje, indivíduos, empresas e profissionais do Direito enfrentam um conjunto de novos e exigentes desafios com relação a conformidade regulatória e fiscal. Os desenvolvimentos recentes na área de transparência fiscal e troca de informações para fins fiscais criaram um cenário competitivo no qual o cumprimento eficiente das leis tributárias é a chave para o sucesso.

O Brazil Tax Conference 2020 discutirá as alterações mais recentes na legislação tributária brasileira na perspectiva do direito tributário nacional e internacional, além de incluir análises de direito comparado em jurisdições selecionadas. Renomados profissionais e estudiosos do direito tributário irão explorar as questões-chave para garantir a conformidade fiscal de planejamentos tributários transnacionais em um cenário de transparência fiscal.

Durante a manhã, serão abordadas as recentes alterações na legislação tributária brasileira e os principais pontos das propostas da reforma tributária em andamento no Congresso Nacional (PECs 45 e 110/2019), tais como a criação do IBS, a modificação no regime JCP, retorno da tributação dos dividendos, entre outros. Haverá também um painel com apresentação estudos de casos abordando o planejamento tributário nos cenários inbound e outbound para diversas jurisdições selecionadas, tais como EUA, México e países da América Latina. A convergência das normas tributárias brasileiras aos padrões da OCDE também será tema de destaque no período da manhã, assim como a análise dos programas de residência fiscal e cidadania para contribuintes brasileiros de alta renda.

Durante a tarde, o foco mudará para o regime dos Preços de Transferência brasileiro e seus reflexos nas transações internacionais e sua convergência com as regras da OCDE. O painel sobre a tributação da economia digital analisará os possíveis impactos da Adoção Global dos pilares da OCDE para multinacionais de tecnologia. A importância da ética e do compliance para a tributação e busca da preservação patrimonial no mundo regulado também serão temas de destaque.

In the academic area, dedicate yourself to studying the subject of tax reform, building bridges between the economic pillars of taxation and the legal design of tax systems. She ran the Center for Tax Citizenship (CCiF) until October 2019. In October 2019 she was appointed Director of the Program of the Special Advisory on Institutional Relations of the Ministry of Economy. In November, was appointed as Special Adviser to the Minister of State for the Economy, being responsible for the tax reform.
