

Uruguay Tax Conference 2023

October 3rd, 2023 - Montevideo

In today's globalized and transparent world, individuals, companies and legal professionals face a set of new and demanding challenges regarding regulatory and tax compliance. Recent developments in the area of tax transparency, information exchange for tax purposes and global taxation have created a competitive landscape in which efficient compliance with tax laws is the key to success.

The Uruguay Tax Conference 2023 will discuss the most recent changes in Uruguayan tax legislation from the perspective of national and international tax law, including the analysis of comparative law in selected jurisdictions. Renowned tax law professionals and scholars will explore the key issues to ensure tax compliance within tax structuring scenarios.

The first panel of the afternoon will cover the main domestic tax aspects such as the latest legislation updates, relevant case law and other crucial topics within the tax practice including free trade zones and anti-money laundering regulations. Next, the discussion will shift to Uruguayan international tax law and will comprise crucial aspects such as the changes implemented in the passive income taxation regime, the new substance requirements that need to be met by taxpayers and recent case law defining tax residency criteria. Furthermore, the second panel of the day will also cover updates to the Uruguayan transfer pricing and tax holiday regimes as well as the status of implementation of Pillar I & II of the OECD.

The second part of the conference will have a more practical approach, addressing a variety of case studies which involve third jurisdictions that are typically considered as economic partners of Uruguay. Concretely, the speakers will present the audience with inbound and outbound investments scenarios in order to explore the tax consequences deriving from such transactions both from an Uruguayan perspective as well as from the standpoint of third countries such as: Switzerland, Liechtenstein, Argentina, Brazil and Mexico.
